## 4. General Terms & Conditions (as of July 14, 2025)

These Terms & Conditions apply to all business relationships between Drivers Lounge – Motorworld Mallorca and its members, regardless of the type or scope of services at the time the agreement is concluded.

The currently valid General Terms & Conditions and the House Rules are displayed at Drivers Lounge – Motorworld Mallorca and are available digitally upon request.

#### § 1 General

- The Drivers Lounge is an exclusive club area within Motorworld Mallorca. Its
  purpose is to create a stylish environment for automotive enthusiasts, business
  partners, and friends of Motorworld with a special focus on quality, discretion,
  and community.
- 2. Members are granted access and use of the services provided according to this agreement and the applicable house rules.
- 3. The membership contract is only established upon written confirmation of membership. You may revoke this agreement within 14 days without stating any reason.
- 4. Upon confirmation, the member agrees to comply with the applicable house rules.

### § 2 Usage Rights

- 1. Membership entitles only the persons listed in the contract and their guests to use the club's offerings and facilities.
- 2. Memberships are generally non-transferable. However, for corporate memberships, registered users may be changed upon written request and approval by Drivers Lounge Motorworld Mallorca.

3. Occasional photo or video content may be created during events. Members hereby consent to the internal use and publication of such materials for club-related reporting.

## § 3 Membership Fees

- 1. Upon confirmation, the one-time registration fee and the first monthly fee become due.
- 2. The member pays a monthly membership fee starting from the confirmation date.

  The club may adjust fees to offset rising costs.
- 3. The registration fee and monthly fee must be paid within 14 days of invoice date.
- 4. Bi-weekly billing is only available with a registered payment method.
- 5. The member authorizes the club to collect all dues via direct debit upon signing the membership declaration. Any costs arising from delayed payments will be borne by the member.
- 6. Offsetting fees or dues against any claims from the club is not permitted.

#### § 4 Termination

- Members may cancel their membership at any time with a three-month notice to the end of the month. The full monthly fee is due for the month of termination. Registration fees are non-refundable.
- 2. The club may cancel memberships at any time with immediate effect, especially in cases of unpaid dues after two reminders or breaches of the agreement or house rules. Registration fees are non-refundable.

#### § 5 Data Protection & Use

- 1. Personal data refers to any information relating to an identified or identifiable person. Drivers Lounge Motorworld Mallorca treats such data confidentially and according to Spanish law and this policy.
- 2. Drivers Lounge may collect, store, process, share with relevant employees, and use personal data in compliance with applicable law. Members consent to this upon signing the membership confirmation.
- 3. Members understand that unencrypted emails offer limited confidentiality.

- 4. Data will not be shared with third parties unless with explicit consent or legal obligation.
- 5. Upon membership termination, all associated personal data usage rights expire.
- 6. Members have the right to access their personal data free of charge by requesting it via email to: bartels@motorworld.de.

## § 6 Liability

 Members are fully liable for any damage they or their guests cause while using club facilities. The operator is only liable for damage resulting from intent or gross negligence. In cases of injury or health-related issues, the operator is also liable in cases of slight negligence if duty of care has been breached.

#### § 7 Legal Jurisdiction

 This agreement is governed by Spanish law. The exclusive place of jurisdiction for any disputes shall be the headquarters of Drivers Lounge – Motorworld Mallorca in Palma de Mallorca, Spain.

### § 8 Severability Clause

- 1. If any clause is or becomes invalid, the rest of the contract remains unaffected.
- 2. Amendments or supplements to this agreement must be made in writing.

## 5. Internal regulations (as of July 14, 2025)

#### § 1 General

- 1. The Drivers Lounge at Motorworld Mallorca is a place of meeting, enjoyment, and a passion for automobiles, aesthetics, and style. It's more than a space it's a mindset: shared by our members, guests, and the culture that unites us.
- 2. To preserve this unique environment and ensure a harmonious experience, we kindly ask you to observe the following house rules. They are binding for all members and their guests.

#### § 2 Access & Membership

- 1. Access to the lounge is reserved for members only.
- 2. Members may only host guests if they are personally present.

- 3. Up to six guests per visit are permitted. The member is responsible for their behavior. Membership rights may not be transferred.
- 4. The Drivers Lounge is a private community. Motorworld Mallorca reserves the right to deny access to any person whose behavior does not align with the club's values.
- 5. Children and teenagers under 18 are only allowed when accompanied by a legal guardian who is a member.

#### § 3 General Conduct

- 1. The Drivers Lounge is a place of refined exchange and mutual respect.
- 2. All guests are expected to behave politely, respectfully, and discreetly, and to be considerate of others.
- 3. Disruptive, intrusive, or aggressive behavior—whether verbal or non-verbal—will not be tolerated.
- 4. All furniture, decoration, and equipment must be treated with care and respect.

  Members are liable for any damage caused by themselves or their guests.
- 5. The Drivers Lounge is politically and religiously neutral. Political or religious discussions, promotions, gatherings, or distribution of materials are not permitted.

#### § 4 Food & Beverages

- 1. The Lounge offers a high-end culinary experience exclusively for members and their guests.
- 2. Bringing and consuming outside food or drinks is strictly prohibited—this includes both alcoholic and non-alcoholic beverages.
- 3. For individual medical requirements or food intolerances, we kindly ask for prior consultation with the center management.

#### § 5 Dress Code

- 1. One's outward appearance is a reflection of respect for the club and its members...
- 2. Entry is not permitted in swimwear, beachwear, undershirts, or flip-flops.

- 3. A look appropriate to the Drivers Lounge is welcome: from well-groomed casual (smart casual) to classic elegant. After daytime events, high-quality leisure outfits are also permitted, provided they align with the ambiance of the venue.
- 4. The center management reserves the right to kindly point out inappropriate clothing and, if necessary, deny entry.

### § 6 Photography and Video Recordings

- 1. Photography and filming in the Drivers Lounge is only permitted with prior written authorization from center management. This applies especially if other members or guests are visible in the footage.
- 2. Publication on social media, in the press, or on any other media platforms also requires explicit permission.
- 3. We protect the privacy of all members and kindly ask guests to respect this as well.

#### § 7 Animals

1. Bringing animals into the Drivers Lounge is generally permitted, provided they are quiet and under control of their owner.

## § 8 Smoking

1. Smoking of cigarettes and cigars – including electronic cigarettes – is permitted only in the designated Cigars Lounge.

#### § 9 Parking & Vehicles

- 1. Vehicles may only be parked in designated parking areas. Access routes, fire lanes, and emergency exits must be kept clear at all times.
- 2. Intentionally generating excessive engine noise as well as aggressive acceleration or revving of vehicles is prohibited throughout the Motorworld Mallorca premises.

#### § 10 Safety & House Rules

- Center management and trained personnel exercise the house rules. This includes the right to deny further access to members or guests who do not comply with these rules.
- 2. In cases of serious or repeated violations, we reserve the right to take further measures including temporary or permanent suspension of membership.
- 3. In emergencies, please follow staff instructions and the marked escape and safety routes.

### § 11 Data Protection & Discretion

- 1. The protection of personal data of our members is of utmost priority. All collected data is handled in accordance with applicable data protection laws and will not be shared with third parties.
- 2. Conversations, interactions, and occurrences within the Drivers Lounge are to be treated as strictly confidential.

## § 12 Amendments & Validity

- 1. The house rules may be updated or supplemented by the center management of Motorworld Mallorca as needed.
- 2. The currently valid version will be posted in the Drivers Lounge and made available digitally upon request.

## 6. SEPA Direct Debit Mandate
